He says: "And not until I was sixteen years old, when my health and strength greatly improved, and my eyes became quite natural, could I read a single verse in the Testament without resting my eyes. I felt keeply the fact that I was behind my school-mates in education."...

- J. Edson, b. in Rocky Hill, Conn., July 28, 1849; he moved with his parents when young to Battle Creek, Mich. Mr. White is President of the Southern Missionary Society of the Yazoo and Mississippi Valleys, incorporated in 1899, also Master and Chaplain of the Missionary Steamer "Morning Star," with northern office in Battle Creek.
- William C., b. in Rochester, N. Y., Aug. 29, 1854; m. (1) in Oakland, Cal., Feb., 1876, Mary E. Kalsey, b. in Lercy, Mich.; she d. in Boulder, Colo., June, 1890; m. (2) in Hobart, Island of Tasmania, Australia, May 9, 1895, Ethel May Lacey, b. in Calcutta, India; she was the oldest daughter of David Lacey, who was for fourteen years in the employ of the British Government as Inspector of Police in India. Mr. White visited Europe in 1885 and '87 and has since been eight years in Australia, but is now (1901) residing in St. Helena, Cal. Children:
